Dear Chief Counsel Hanson,

Thank you for your time and efforts to understand the details and purpose of the criminal report filed with your office September 7, 2018 on behalf of all Big Sky Mineral Resources, LLC members in good standing. Your time and attention to this matter are greatly appreciated.

As you requested in our phone conversation on or about October 3, 2018, this submission will provide some critical evidence concerning the foundational issues addressed in the original report you have reviewed.

During our conversation, you stated the following, all of which were inaccurate statements...

1. Big Sky Mineral Resources, LLC was a Ponzi scheme from the start (false)
2. John Kevin Moore was charge with and convicted of that Ponzi scheme (false)
3. Big Sky Mineral Resources, LLC no longer exists (false)
4. I resigned as a member of Big Sky Mineral Resources, LLC (false)
5. No further members exist in Big Sky Mineral Resources, LLC (false)
6. Lynn Egan did not provide any false testimony against John Kevin Moore (false)
7. The Big Sky Mineral Resources members claims were resolved by the conviction of John Kevin Moore (false)

The result of these misperceptions was that you saw no need to investigate anything in the criminal report delivered to Commissioner Matthew Rosendale on September 11, 2018. On this basis, I am pleased to provide you with some of the information you have requested to back up the foundational claims in our report to Mr. Rosendale on September 11, 2018.

1. Included is a copy of the Montana State record confirming that Big Sky Mineral Resources, LLC still exists as a Montana company in good standing.
2. Included is a copy of the Superseding Indictment of John Kevin Moore, which as you can see, had nothing to do with Ponzi, Securities or Insurance fraud.
3. Included is a copy of my resignation letter, resigning as "managing" member, but not resigning as a member in good standing of Big Sky Mineral Resources, LLC.
4. Included is a copy of Ms. Lynn Egan's "false" testimony in which she wrongly accuses Big Sky Mineral Resources of both Ponzi and Securities fraud, leading to the Federal investigation and ultimate collapse of Big Sky Mineral Resources, LLC upon the expiration of our oil and gas leases still held under government TRO as of today.
5. As you know, until all Big Sky Mineral Resources, LLC members are made whole for their investments, the matter is not resolved for any BSMR member. We have a right and obligation

to report what we believe to be criminal activities by others beyond Kevin Moore, which directly contributed to the demise of Big Sky Mineral Resources and horrific financial losses to all Big Sky members in good standing.

Thank you for offering to review these facts in good faith, as Chief Legal Counsel for the Office of Commissioner Matthew Rosendale, CSI. I'm certain that you, Mr. Rosendale and the Montana CSI would like to make sure that everyone we reported to your office is officially cleared of any wrongdoing, especially as Mr. Rosendale is seeking a seat in the United States Senate.

Thank you for your prompt attention to these matters. In the sake of time, as we are all very busy people, I am only including evidence proving the foundational claims made in our original report. In the event that you decide to open an investigation into these matters, I will be happy to provide additional evidence concerning the others named in our report.

Thank you again for your time and good faith efforts to help all Big Sky members seek restitution from all who are responsible for the demise of our otherwise legitimate and promising venture.

All Big Sky members for which I have contact information, are being updated and apprised as we pursue justice on their behalf. Due to the very sensitive nature of such matters, I request that you officially respond to this request for an investigation, in writing.
