RE: Very Pressing Matter

Secretary Zinke,

First, on this Veterans Day, let us thank you for your Military service to our great country and your continued service as the United States Secretary of the Interior.

We are sending this to you via private confidential communication so that you can use the information enclosed to your best advantage. We are quite aware of the politically motivated witch hunt targeting you, recently passed to the Department of Justice, which may in fact be the deepest swamp in the USA today. It's more accurately referred to as the Department of NO Justice.

We are also aware of ongoing efforts by Montana Democrats to target you and the Trump Administration from the "halls of justice" at the state level. We want to share with you what we know, after 10 months of in-depth independent research and investigations.

1. At the center of the attacks on you personally are two hi-profile Democrats in Montana, Senator Tester and his ally on the Federal bench, Judge Brian Morris. It is no coincidence that Judge Morris has been blocking the Trans Canadian pipeline, or that Judge Morris ruled that pipeline dead again, less than 24 hours after Tester was able to hold on to his Senate seat in last Tuesday's election.
2. Key to the Tester/Morris operation back in Montana is your good friend Matt Rosendale, Montana Commissioner of Securities and Insurance. Commissioner Rosendale holds the key to freeing the pipeline and ending the witch hunts targeting you, though he may not know it right now.
3. As you know, a dear friend and supporter Kevin Moore has been wrongly arrested, held without bond and convicted on charges that he is entirely innocent of. You also know that the case started as a political witch hunt against you during your 2016 re-election bid for the House of Representatives. That witch hunt was started and guided by Montana Democratic Party operatives Denise Juneau, Lynne Egan and Ms. Lindeen, the then Commissioner of Securities and Insurance for Montana.
4. You also know that MG Paul E. Vallely was instrumental in the Big Sky set up and demise, having turned against you and Kevin Moore back in 2016, after failing to hijack Big Sky for his personal profit.
5. Key players in both the Kevin Moore case and the witch hunt against you, as well as the hold up of Trump's Trans Canadian pipe line, are MG Paul E. Vallely, Judge Brian Morris, Senator Tester, Denise Juneau, Ms. Lindeen and Lynne Egan.
6. Although Ms. Juneau failed in her effort to claim your House seat in 2016, she succeeded in destroying Big Sky Mineral Resources, LLC, Kevin Moore and the Trans Canadian pipeline, while keeping the witch hunts against you alive and well.
7. As you likely know, the original "evidence" of "Ponzi and securities fraud" against Kevin Moore were false and based upon the fraudulent testimony of Lynne Egan, who is still employed by

Matt Rosendale at Montana CSI. You may also know that Kevin Moore is not the first case like this for Lynne Egan, there has been many, including the destruction of Navy SEAL Rob O'Neil's father. Ms. Egan is a pure political operative in the CSI office under Matt Rosendale and should be charged with numerous crimes herself.

8. Additionally, Judge Morris's sentencing agent Tony Wells, has just filed a totally fraudulent and false report aiming to keep Kevin Moore in prison until his death. It was never anything more than a political witch hunt to hang a patsy in Kevin Moore, when in fact, MG Paul E. Vallely and numerous others were at the foundation of the demise of Big Sky, working with Lynne Egan at the State level and Federal Prosecutor Weldon, all of whom are Democratic Party operatives in Montana positions of power.
9. Last, Judge Brian Morris should have recused himself from the Moore trial, as a close-contact DNC ally of Denise Juneau, Lindeen and Egan. Instead, he declined change of venue, declined motions for a mistrial by Mr. Moore's counsel and prevented Moore from having any real defense by allowing the prosecution 4.5 days to present (fake evidence) and the defense only .5 days to present a very limited defense.

Now, we know what Mr. Moore's loyalty is to you and we have been told that you are a loyal friend of his as well. As a result of the corruption that took place under Matt Rosendale's office, against Kevin Moore, involving even Judge Brian Morris, we believe that you and Kevin have a critical common interest here...

The goals?

1. To end the witch hunts against you
2. To find true JUSTICE for Mr. Moore
3. To remove Judge Brian Morris from the bench due to his behavior in the Moore case, and free up the Trans Canadian pipeline
