CREDIT UNION MEMBER AFFIDAVIT AND PETITION FOR JUDICIAL NOTICE

We the undersigned, being Montana State Residents, Whitefish Credit Union ("WCU") Par-Members, concerned Citizens, and Advocates for Banking transparency, do hereby Individually, and together swear upon Oath and Affirmation, that the foregoing statements are true to the best of our understanding and knowledge.

NOTICE

On May 22nd, 2023, we were made aware of certain "5300 Reports," that all Credit Unions must regularly file, including WCU. Regarding these certain specific 5300 Reports before the Court today, Member Petitioners argue they have standing to Report to the Court, and that the Court has Original and Superior Jurisdiction in this matter.

Member Petitioners continue, that these particular reports are substantial to this Court, as they recorded the transaction of the "Somers property," currently being adjudicated in this Court.

Member Petitioners further argue jurisdiction, as on August 3rd, 2023 – Member Petitioners met with Flathead County Attorney Travis Ahner, to get these reports on the record. Upon receipt of our verbal report and concerns, Mr. Ahner alluded that while the matter with: ["Thorco, Dennis Thornton, et al, was currently being adjudicated in Fed. Bankruptcy Court, he would not act, and that Member Petitioners should approach the NCUA and/or another venue."]

Member Petitioners, upon their own Due Diligence and Research, discovered the NCUA had already been contacted a 'handful of times,' on this matter, and that they would only regulate and would not be investigating. Armed with this knowledge, Member Petitioners chose to acknowledge this Court's jurisdiction, and have acted accordingly with this Notice.

EVENTS

On May 25th, 2023 – Member Petitioners (together), went to the Office of the Flathead County Sheriff, Brian Heino, with a Complaint with accompanying Evidence. Subsequently, Case#2023-15642 was officially opened to investigate 4 Million dollars purportedly 'missing' from specific WCU 5300 Reports. It was discovered that these reports are directly tied to the sale of the property before this Court (Somers Montana), and that it is uncertain if there was a transaction at all; if there was a transaction, Member Petitioners argue this Court should officially Take Judicial Notice of this Matter, and add it to the Evidence before this Court, and add it to the Public Record.
