Subject: Absolutely NO to H.R. 3773 & S. 1967

Please vote NO on both these bills.

The federal and State law covers what is in the Protect Act. These two bills are an existential threat to the civil liberties of all Montana Citizens and all other reservation states. This bill is targeting non tribal members for any reason when the tribes cannot control or jail or imprison their own tribal members. called Protect Act does the opposite, it is setting up the non tribal State Citizens to take away their gun rights and their legal defense rights.

These 2 bills should never have been written up let alone got this far. The tribal reservation system is a mess in the states and at the federal level. The BIA should be DEFUNDED, ELIMINATED and all subsidies to the tribes stopped immediately. There are some 562 tribes with 400 more standing in line for more government handouts. Allowing gambling on reservation to make them independent did not work. In reality, it makes them more dependent and more troublesome on all the other property owners and neighbors in the area. Casinos are an attractive nuisance for more drug dealing on the reservations.

There are some 500, 000 tribal members in a US population of 342 million now. This is only 0.15 % of our population. [The BIA budget for 2024 is \\$3.0 billion!](#) This is insane. We need to eliminate all race based funded programs. If the tribes have not assimilated after more than a century the current system of keeping them dependent is not working!

The tribes are not sovereign, i.e. they are domestic codependents. The Indian caucus in Helena is not friends to the Montana Citizens. Few in Montana legislators know Montana Indian policy. Montana State does not care about Indian affairs. Montana US Senator Steve Daines does not care about the non tribes Citizens. It is obvious he is political favoritism to the tribes at the expense of all other non tribe Citizens. He played this same card pushing the CSKT water taking compact which should also been shredded. Lake County tax payers are forced to pay the CSKT \$6 million for their court system costs. Only 10% of Montana Citizens understand the issues living near a reservation. The Montana tribal leaders cannot effectively manage their own members and that is way 80% of the tribe live outside their reservation.

It is suspected the CSKT tribe wrote this Montana Bill with the help of a US Senator from Minnesota, Tina Smith (D). The language is being changed in prior bills to broaden the bills influence. I hear James & Dinky are pushing the Protect Act bills into Senate after House has passed.


